### WAFCS Bylaws Update



Bylaws are the most basic rules of operation for our organization. They should cover only the highest level of operation of the board. Think of the bylaws as equivalent to the U.S. Constitution—broad in the topics

it covers and infrequently changed—while the policies you pass are more like the laws that fit within its framework. Every time Congress passes a law, it doesn't have to amend the constitution. Keep your bylaws focused on the big picture and use policy to enact other changes.

Reviewing the organization's bylaws is a basic part of every board's legal duties. Well-drafted bylaws will signal a well-governed organization, which will be an important factor for internal and external stakeholders, including potential directors, employees, funders, major donors, and regulators.

It has been five years since the Executive Board of WAFCS updated the Bylaws. Some items were outdated, some offices were found to be unnecessary, and AAFCS had requested that the Affiliates align their Bylaws with theirs. The board has been working on the revisions for more than a year, and are now ready to present them to the membership for approval.

The proposed Bylaws revisions will have been sent to all members by the time this newsletter reaches you. These revisions will be voted on at the Annual General Meeting on Thursday, October 29. The revisions can also be viewed on the WAFCS website at
